



## NOTICE OF PLANNING ASSESSMENT COMMISSION MEETING

The Department of Planning and Environment (DP&E) has completed its assessment of the above development application. The application has been referred to the Planning Assessment Commission (the Commission) for determination, under the terms of the Minister's delegation.

Due to the level of public interest in the proposal, the Commission will be meeting to hear public views on the DP&E Assessment Report and recommendation, prior to determining the application. The Commission therefore welcomes written comments on projects **up to one week after the public meeting**. Written comments will be weighed equally by the Commission to verbal presentations.
